


Canadian companies are strengthening Florida's innovation ecosystem, driving advancements in simulation, training, life sciences, and AI-driven healthcare solutions. **CAE**, a leader in simulation technologies, employs over 750 people in Florida and is expanding capabilities in pilot and aviation training. **Avalon Holographics** and **Bluedrop Training & Simulation** are enhancing defense training with cutting-edge technologies.

In healthcare, Canadian companies partner with the Mayo Clinic Innovation Exchange to revolutionize medical technologies. Innovators like **Bowhead Health** and **Gray Oncology Solutions** are developing groundbreaking solutions, with Gray Oncology participating in Tampa's Moffitt Cancer Center's CancerX Accelerator.

These partnerships accelerate technological progress and economic growth, positioning Florida at the forefront of global innovation in defense, healthcare, and emerging technologies.


Canadian firms support Florida's future

Canadian consulting engineering firms are key partners in modernizing Florida's infrastructure. Companies like **Stantec, AtkinsRealis, EXP, WSP**, and **RWDI** are involved in various projects across the state, improving transportation and clean water systems. Plenary Americas manages public infrastructure, including the Miami Dade County Civil and Probate Courthouse.

Stantec is designing a \$212 million academic health sciences and clinical facility for Florida International University and Baptist Health South Florida, addressing a physician shortfall by creating 22 graduate medical education programs. AtkinsRealis is working on a 23-mile project along Interstate 75 to alleviate congestion and enhance safety. Stantec is also advancing the Tampa Bay Water potable water supply project, ensuring a reliable clean water supply for Hillsborough County.

These projects highlight the critical role Canadian firms play in advancing Florida's infrastructure and healthcare, ensuring a brighter future for Floridians.
