**Davis County exports \$86 million in goods to Canada annually**

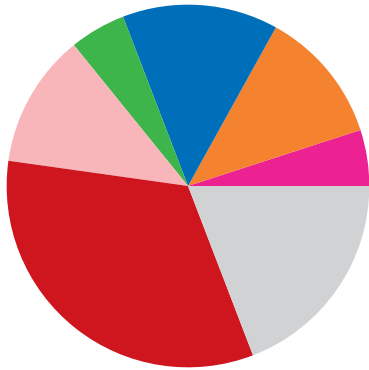
