

### Canadian innovation boosts U.S. aviation training & workforce development

**CAE**, a Canadian leader in aerospace training and simulation, has opened its first Gulfstream-dedicated business aviation training center in Savannah, Georgia, near Gulfstream Aerospace's headquarters. This new facility will train more pilots and maintenance technicians, addressing the growing demand for skilled aviation professionals in the U.S.

The center will house up to four full-flight simulators, with the first—a Gulfstream G550 FFS—already operational, and a second, a Gulfstream G280 FFS, set to follow. In addition to pilot training, the center provides advanced maintenance training using virtual reality for Gulfstream G280, G650, and G500/G600 jets. CAE's cutting-edge technologies, including CAE Rise™, will enhance training through real-time insights and data analytics.

As part of CAE's global network of business aviation training centers, the Savannah facility will play a critical role in meeting the projected need for 32,000 pilots and 74,000 maintenance technicians by 2032. This Canadian investment strengthens the U.S. aviation sector, ensuring a highly trained workforce to support the future of business aviation.

## Canadian investment drives job creation & manufacturing growth in Georgia

Titanium acquires Crane Transport
