Building a hydrogen network

Pennsylvania-based global industrial gases company **Air Products** is the world's largest hydrogen producer and Canada's leading hydrogen supplier, with two existing production facilities and a third under construction in Alberta. As the market for lower-carbon fuel sources takes off, Air Products has begun construction on the new \$1.6 billion net-zero hydrogen energy complex in Edmonton, Alberta.

Supported by investments from the Canadian and Albertan governments, Air Products will use its cutting-edge technology and benefit from the area's skilled workforce to build the most competitive and lowest-carbon-intensity hydrogen network in the world. As part of its net-zero complex in Alberta, Air Products will also build a liquid hydrogen production facility that will contribute to continental energy security, while centering Air Products at the forefront of the hydrogen for mobility applications evolution across Canada and North America.

Canadian investment powers U.S. clean energy & job growth

In 2023, Canada's leading uranium producer, Cameco, and Canadian investment firm Brookfield acquired Westinghouse Electric Company, a Pennsylvania-based nuclear energy leader. This partnership strengthens energy security and expands clean energy innovation.

Westinghouse's next-generation eVinci microreactor provides carbon-free, transportable, and scalable nuclear power, offering a clean alternative to diesel-reliant communities. The investment is also driving job growth, supporting well-paying jobs in Etna, PA, where Westinghouse has repurposed a former steel mill for its eVinci accelerator, and in Burlington, Ontario.

By combining Cameco's nuclear expertise with Brookfield's clean energy leadership, this Canada-U.S. collaboration is accelerating the clean energy transition and expanding the renewable energy workforce across North America.

Wesco thrives in Canada

Pittsburgh-headquartered Wesco Distribution is a global electric instruments and controls OEM provider for infrastructure and technology projects. It is ranked #370 on the Fortune 500 list and posted sales of \$21.4 billion for 2022. Approximately 15% of its business is in the Canadian market, with 3500 Canadian employees where it is primarily focused on broadband and grid modernization with concentration around the main population centers. It serves telecom providers and the development of data centers for tech companies. Wesco also support energy transition projects in British Columbia and Hydro in Quebec.
