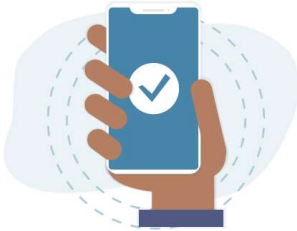


Fully vaccinated travellers returning or travelling to Canada

If you're planning to travel to Canada, it's important to be aware of the mandatory requirements that protect both you and people in Canada from the spread of COVID-19.

Travellers need to use the ArriveCAN mobile app or sign in online at Canada.ca/ArriveCAN to submit mandatory information digitally before boarding a flight or crossing by land into Canada. There may be some exemptions for fully vaccinated travellers who are currently eligible to enter Canada. To be considered fully vaccinated, travellers must have received a full series of a [Government of Canada approved COVID-19 vaccine](#) (or a combination of vaccines). Travellers must receive their last dose at least 14 days prior to the day they enter Canada.



STEP 1

Download the ArriveCAN mobile app or sign in online at Canada.ca/ArriveCAN.

Planning a trip? Visit Canada.ca/ArriveCAN for details about the mandatory requirements. Being prepared will save you time and effort as your travel date approaches.



STEP 2

Take a COVID-19 molecular test within 72 hours before your scheduled flight.

All travellers 5 years of age or older, regardless of citizenship, must provide proof of a negative COVID-19 molecular test or evidence of a positive COVID-19 test taken 14 to 90 days prior to arrival in Canada.



STEP 3

Enter your information in ArriveCAN before you board your flight or leave for a land border crossing.

Use ArriveCAN to submit your travel and contact information, your quarantine plan, a COVID-19 symptom self-assessment and your proof of vaccination. Once complete, you will receive an ArriveCAN receipt.



STEP 4

Upon arrival in Canada, you'll need to provide your proof of vaccination, complete your on-arrival test and answer questions about eligibility, vaccination and health screening.

If you meet the exemption criteria for fully vaccinated travellers, you won't need to quarantine or complete a day-8 test. If arriving by air, you also won't be required to stay at a hotel to await your on-arrival test result. If you don't meet the exemption criteria, follow the instructions provided upon arrival.



STEP 5

If you received a home test kit, complete it and send it to the lab.

If your on-arrival test is positive, you must follow the instructions of your local public health authority. Keep your proof of vaccination for 14 days.

ArriveCAN is free and can be easily downloaded as an app, or you can sign in online. ArriveCAN does not use any technology or data to monitor or track traveller movements, so your privacy is always protected. Find out more about ArriveCAN at Canada.ca/ArriveCAN.

Some fully vaccinated travellers who are currently able to enter Canada may be exempt from the 14-day quarantine requirement. Find out more at travel.gc.ca/travel-covid. If you violate any instructions provided to you when you enter Canada or break your mandatory quarantine or isolation requirements, you will be faced with a penalty and fine.
